

MSSNYPAC REPORT TO THE MSSNY COUNCIL

This report reflects the financial status of MSSNYPAC during the 2024 fiscal year period of 1/1/24 through 6/20/24. We have collected \$86,601.31 from 240 individual supporters. Each dollar contributed to MSSNYPAC is split between operating expenses and contributions to candidates in a ratio of 2:8. For comparison, prior calendar year collections are as follows:

2023: \$141,442.15 from 377 supporters.

2022: \$162,304.41 from 477 supporters.

2021: \$186,249.37 from 451 supporters.

2020: \$151,682.21 from 408 supporters.

2019: \$235,978.86 from 636 supporters.

2018: \$256,177.60 from 722 supporters.

Scorecard. The 2023-2024 Legislator Scorecard is under development and will be sent out as soon as it's complete. Many individual county scorecards will also be made available for download at www.mssnypac.org.

House of Delegates. MSSNYPAC had a very successful 2024 House of Delegates with nearly \$110K in pledges of support from close to 200 individuals. Thank you! MSSNYPAC physician leaders along with Senator John Liu and Assemblymember Steve Rhoads discussed the importance of getting involved in advocacy and physicians told personal stories of their relationships with legislators, incorporating advocacy into their medical practices, and working together to achieve legislative victories. Moreover, many county delegations achieved 100% PAC participation. A generous physician challenged all students and residents to join and offered to match their donation! As always, we thank each and every supporter for their generosity and commitment to MSSNYPAC which is an essential part of MSSNY's physician advocacy strategy.

Political Events. Your MSSNYPAC support has enabled physicians and lobbying staff to participate in over 50 political events held by legislative leaders, physician-hosted events and multi-specialty society events. Web and Data Transition. Along with all of MSSNY, MSSNYPAC is working to complete a data migration to a new database and website. Our highest priority is a seamless, unincumbered donating experience.

Physician Advocacy Liaison Network (PAL). Every NYS Senator and Assemblymember should have at least one Physician Advocacy Liaison identified going into the 2025 legislative session. PALs have an existing personal relationship or intentional professional relationship with an elected official and are available to contact their legislator at specific points during the legislative development cycle in order to

relay pertinent information to their legislator. With so many new legislators filling long-held seats, this is a crucial advocacy tool. Please sign up to be a PAL at www.mssnypac.org.

LLC/PLLC Donors. After discussion with the Board of Elections on June 18th, 2024, further guidance was provided to MSSNYPAC pertaining to disclosure of physician residential addresses. The BOE understands the need for certain occupations to maintain private residential addresses. Owners are permitted to enter their business address on their Statement of Identity form and simply annotate that the residential address is private.

If you donate to MSSNYPAC in 2024 through your PLLC or LLC, you are required to submit a Statement of Identity to the NYS Board of Elections by December 31, 2024. You may download the form from the NYS Board of Elections <https://elections.ny.gov/additional-campaign-finance-forms>. Please forward the completed and signed form to cinfo@elections.ny.gov with a copy to mssnypac@mssny.org. A Statement of Identity is required to be submitted for each year in which an LLC/PLLC makes a political donation.

Partnerships. If you donate to MSSNYPAC in 2024 through an incorporated or unincorporated partnership and that donation exceeds \$2,500, you must disclose the individual partners names and addresses with percentage of donation attributed to each partner.
